- 16. First West's representative will contact the Selected Recipient by phone or email by Monday, March 18, 2024 to confirm compliance with these Terms and Conditions. The Selected Recipient must contact First West by email (marketingservices@envisionfinancial.ca) by no later than March 31, 2024 to arrange for the administration of the Skill-Testing Question and make arrangements to the claim the Prize.
