

Three Months Free Unlimited Chequing for Business® Offer: Terms and Conditions

By participating in the Three Months Free Unlimited Chequing for Business® Promotion (the “Offer”), all participants agree to abide by these Terms and Conditions (the “Terms and Conditions”). By participating in the Offer, you understand that you are providing your information to First West Credit Union (“First West”), and any information provided will be used in accordance First West’s privacy policy.

Offer

1. The Offer is available to an Eligible Member (as defined below) and consists of Three Months Free Unlimited Chequing for Business® (an approximate value of \$90.00 CAD) when an Eligible Member opens a First West membership with an Unlimited Chequing for Business account (the “Account”).
2. The Offer is open only to those entities that are residents of British Columbia and is not open to individuals.
3. The Offer is valid at any Envision Financial branches, a division of First West Credit Union.

The Offer begins on May 21, 2022. The Account must be opened by 5:00 pm Pacific Standard Time (“PST”) on June 30, 2022.

4. No purchase is necessary.

Eligibility

5. The Offer is open to entities who:
 - a. Reside in British Columbia; and
 - b. are over the age of 19 on the date that he or she opens the new business membership (an “Eligible Member”).
6. To be eligible to receive the Offer, an entrant (or a representative of an entrant) must:
 - a. Have attended the Brewhalla Beer + Music Festival at the Fort Langley Park on May 21st, 2022, which runs from 12:30 PM PST to 6:00 PM PST;
 - b. Book an appointment with a representative from the Business Services team ([Contact Us | Envision Financial](#)); and
 - c. Open the eligible Account prior to June 30, 2022.

Conditions to the Offer

7. This Offer is available to Eligible Members only.
8. Directors, employees, contractors, agents and other representatives, and their respective immediate families of First West, or any of their affiliates, divisions, or promotional agencies are not eligible to receive the Offer.
9. Only (1) one Offer is available per Eligible Member.
10. The Offer and these Terms and Conditions do not, in any way, affect the standard Account terms and conditions or any other member agreements, terms or conditions, or policies of First West, which continue to apply upon opening the Account with First West.
11. This Offer cannot be combined with any other offer or reward.
12. The Offer must be accepted as awarded and cannot be transferred, exchanged, or assigned. No cash substitutions will be permitted.
13. First West reserves the right, at its sole discretion, to cancel, modify, withdraw, terminate or suspend this Offer, in whole or in part, at any time for any reason without notice.
